NO FLY AREAS				
LOCAL HAZARDS	A number of private, unlicensed strips exist within the CTR, these may be active at any time. Departure from marked movement areas can be hazardous. KEEP OFF THE GRASS.			
HELICOPTER OPERATIONS	Training area north end of Taxiway Foxtrot. Circuits to North West, parallel to active runway, at 700ft QNH or as instructed by ATC. Clearance to cross runway is ALWAYS required. Police, HEMS, Military and rescue helicopters may operate at any time and may be given priority departure over all other traffic .			
SPECIAL RULES	Passengers may NOT be embarked / disembarked with engines running GA parking as directed by ATC. NO GRASS PARKING Subject to Pilot and ATC. Preferred runway in use (tailwind Max 5kts) is Departures runway 06. Arrivals runway 24. E.G. To / From the EAST. ALL VFR flight within the CTR REQUIRES a Flight Plan to be filed. All A/C to squawk mode Charlie whilst airborne.			
REMARKS	Runway 06. A/C able to depart from B1 / F, Must inform ATC on start up. VFR A/C inside the CTR will be given routings and levels to integrate with IFR traffic. IFR has precedence at all times, as directed by ATC. Pilots should remain VMC AT ALL TIMES and advise ATC if they cannot maintain routing and levels as instructed. Arriving A/C should contact Southend AT LEAST 5 minutes BEFORE entry to the CTA, CTR Zone boundary. Pilots wishing an OVERHEAD JOIN should request it ON FIRST CONTACT with ATC. VFR A/C will be expected to use the following VRPs as instructed. Billericay; South Woodham Ferrers; Northey Island; Southminster (lake); Whitstable Harbour; Southend Pier; Sheerness; Gateway port.
